DNREC Sand Bypass Facility, Indian River Inlet, Bethany Beach, DE

DUTIES

The Conservation Technician V position will oversee the operation of the Sand Bypass Plant at Indian River Inlet, including the slurry and water pumps, diesel engines, eductor pump, a 160 ton crawler crane, earth moving (e.g. bulldozer), and support equipment. The position will also: supervise subordinate personnel assigned to the bypass plant; maintain a project schedule to attain the desired goal of bypassing 100,000 cubic yards of sand from the south side to the north side of the Inlet each year; maintain a daily log of all activity and quantities pumped while the plant is in operation; develop and maintain a maintenance schedule for all pumps, diesel engines, and other support equipment and vehicles; assist staff with maintenance and repair work to all equipment as needed; work cooperatively with project representatives from the U. S. Army Corps of Engineers; manage the inventory of supplies and material for the operation of the bypass plant; and conduct tours of the sand bypass facility when requested.

REQUIREMENTS

1. Three years' experience operating hand power tools, land-based and/or marine-based construction equipment used for grading, excavating, pumping, or dredging.
2. Three years' experience of routine maintenance of land and/or marine construction equipment light trucks and vessels.
3. Must have the ability to perform physical labor and lift up to 50 lbs.
4. Possession a valid Driver's License (not suspended, revoked or cancelled, or disqualified from driving).
5. Must possess a valid class A Commercial Driver's (CDL) or be able to obtain a CDL license within 90 days of employment.

BENEFITS

The Kent Conservation District offers a comprehensive benefit package including: 37.5 hour work week with flexible scheduling options, 15 paid vacation days the first year, 9 paid holidays a year, and 15 paid sick leave days per year.
